Why does DMHA need this data?

- Grant reporting
 - Substance Abuse Prevention and Treatment Block Grant
 - Mental Health Block Grant
- Performance Measures
- Consumer Outcomes

Consumer Page Change

- In order to aid with matching in DARMHA, we are moving the Medicaid/HIP ID to the Consumer page from the Episode page.
- Active Medicaid field will still be on the Episode page.

Episode Page Changes

- Medicaid ID/HIP ID will move to the Consumer page.
- If you close an episode as “Episode Status = Death,” you cannot open up a new episode.

New Diagnosis List

- The new diagnosis list will be posted by early July. The list will include eligibility information for MRO, AMHH and BPHC and will include whether a code can be a primary diagnosis.
- DSM 5 only or pertinent ICD-10 Codes? (If you have rationale for either option, please email me at wendy.harrold@fssa.in.gov.)

Submitting Diagnosis Data

- New codes and diagnosis data required starting October 1, 2015. No old codes will not be accepted after September 30, 2015.
- You will need to submit a new diagnosis record for all SFY 2016 consumers, including those only seen in July, August and September. (Records need to be submitted after September 30, 2015.)

- Diagnosis Date
- Diagnosis Record ID
- Five fields for diagnoses (the first one being the primary diagnosis)
- SOGS score
- Agreement Type
- Specialized treatment
- Agreement Change and...

Health Conditions on Diagnosis Page

- Diabetes
- Cardiovascular Disease
- Hypertension (high blood pressure)
- Hyperlipidemia (high cholesterol)
- Cancer
- Smoking
- Obesity
- Asthma
- COPD

CANS/ANSA Changes

■ Changes to the ANSA

- Changes to development disability item language
- Three new items in a health module triggered by the physical/medical health item
- The Crime Module will be triggered by both legal and criminal behavior items
- Four new items in the trauma module to be more consistent with the CANS and move towards trauma informed screening and assessment

■ Changes to the CANS

- Changes to the developmental item and module. The format for the new DD module has been enhanced with four new items and new definitions and questions to assist in rating the items

CANS/ANSA Changes

- Change in the algorithm for LON 4 for birth-five tool that will enable more young children who need intensive community based services to access them
- New ways to provide the data (export? reports?)

- Additional data submitted with assessment
 - **SMI/Co-Occurring Carve-Out** (0 = No; 1 = Yes):
Consumer is receiving services as part of the SMI/Co-Occurring Carveout program

NOMS Page Changes

- **Addition of two EBPs from the EBP Page**
 - **Supported Employment** (Integer): Is the consumer involved with supported employment? (Same options as last year)
 - **Supported Housing** (0 = No; 1 = Yes): Is the consumer receiving supported housing?

EBP Page Changes

- This page will only contain historical data.

Import Changes

- New import option for closing old episodes
- New import for assessment information
- Proposing closing an episode when a discharge assessment is completed

Testing SFY 2015 Changes

- Manuals will be available by early July.
- We will be implementing SFY 2016 changes in QA incrementally. All the changes, including the new CANS/ANSA question data, will be available for testing in QA by September 1st.

DARMHA QA – Testing Environment

- The test environment - <https://dmhaqa.fssa.in.gov/DARMHAQA>
- We have been told by our state HIPAA staff that **no real data can be in DARMHA QA.** Data has to be test data. We will be checking to see if providers are putting in real data – if they are, the data will be wiped out.
