# **Summary of SFY 2014 DARMHA Data Changes**

### **New Rules:**

- Once an episode is closed, the episode data can only be edited for <u>180 days</u> after the episode end date. Also, once an episode is closed, new data can only be added for 180 days after the episode end date.
- A NOMS, EBP, Diagnosis/Agreement Type records and Encounters can only be <u>edited for 180 days</u> after the date of submission to DARMHA. Encounters can also only be <u>deleted for 180 days</u> after the date of submission to DARMHA.
- Episodes must be open for at least one day.
- You cannot close an episode and change the agreement type using the same date. Once a new agreement type is submitted, an episode must be open for at least one day.
- The date of the first diagnosis/agreement type record must be the same as the episode start date.
- Due to the new format, editing diagnosis and agreement type records from before 7/1/2013 will not be allowed.

### Consumer Data:

Optional - Suffix (Integer): Utilize if consumer has one of the following suffixes in his name.

-2 = None

1 = I (First)

2 = II (Second)

3 = III (Third)

4 = IV (Fourth)

5 = V (Fifth)

10 = Jr.

11 = Sr.

## **Episode Data:**

**Legal Basis of Referral** (Integer): Was the referring source of a legal basis? If 7 = Court/Criminal Justice in "Source of Referral", this information is required. (Changed a few options to match federal wording)

- -3 = Not Applicable
- 1 = State/Federal Court
- 2 = Other Court (not State or Federal)
- 3 = Probation/Parole
- 4 = Other Recognized Legal Entity (E.G. local law enforcement agency, corrections agency, youth services, review board/agency)
- 5 = Diversionary Program (e.g., TASC)
- 6 = Prison
- 7 = **DUI/DWI**
- 8 = Other

# **HAP is now DMHA Supported Consumer (DSC)**

### **DSC Status**

- 0 = Not a DMHA Supported Consumer This is the default.
- 1 = DMHA Supported Consumer
- 2 = DMHA Supported Consumer Medication Only

**DSC Status Start Date (MM/DD/YYYY):** For new episodes, this field will be **automatically** populated with the episode start date. When the status is changed, a date will be required. **No future dates, no date before the Episode Start Date and no date before a previous DSC Status Start Date are allowed.** 

## **Diagnosis and Agreement Type Data:**

The Diagnosis record now includes the agreement type data.

Deferred Diagnosis or No Diagnosis Codes will not be allowed as the Primary Diagnosis.

**Specialized Treatment** (Integer) **[Optional]**: (Formerly called **Funding Type** – No longer have option 3 – Deaf Gambling)

- -2 = None
- 2 = Deaf Services
- 4 = Opioid Treatment (Must be CA agreement type)
- 5 = Gambling Treatment

**Agreement Change** (Integer): (Formerly called **Agreement Funding Change** – No longer have option 4 – Released from Special Funding)

- 1 = Initial
- 2 = Refined Diagnosis
- 3 = Special Funding Requested (Use when requesting funds for Deaf Services or Opioid Treatment. Funding is only provided to organizations that contract with DMHA to provided specialized services.)

### **Assessment Data:**

New items (questions) and labels for items and item options; refer to CANS or ANSA manuals or the Assessment Tools Export.

#### **EBP Data:**

Note: The CA-PRTF program ended in the fall of 2012. However, since this field was not originally listed as one of the SFY 2014 changes, we are keeping it in the Import and Web Services. It is an optional field now.
